EXTENDED Deadline Date for Submissions: March 6, 2023

Criteria for Submission:

- Florida artists of all abilities are invited to submit up to three JPEG images for consideration.
- Each entry must be an original work of art and can be two-dimensional or sculptural.
- Each entry must include the artist's name, title of work, medium, and dimensions (H x W x D).
- Each work of art must be accompanied by a unique artist statement on a separate page.
- Submissions must not exceed 36"x36"; 10 pounds is the maximum acceptable weight.
- Two-dimensional works **MUST** be gallery wrapped or framed and wired for hanging.
- Shipping and delivery details will be sent to selected artists. Selected artwork must be shipped or delivered to **NextStep at Endeavor Academy, 2864 Madison Street, Marianna, FL 32448** by April 12.
