Voices & Visions Artist Addendum Agreement with Arts for All Florida

Sale of Works

The Lee County Alliance for the Arts reserves the exclusive right to sell the Works during the term of this Agreement at the price listed on each Work and will collect sales tax on all sales as required by Florida law. No sales on approval or credit shall be made without the prior written consent of the Artist. None of the sold Works may be removed prior to the close of the Exhibition. All funds collected by the Alliance will be distributed as follows: (a) sales tax will be deducted from gross proceeds and transmitted to the Florida Department of Revenue on Artist's behalf; (b) Artist will receive sixty (60%) percent of the remaining proceeds; and (c) the Alliance will receive forty (40%) percent of the remaining proceeds. All payments will be made within thirty **(30) days** following the close of the Exhibition. Arts4All Florida is not receiving commission from the sale of Work.

Marketing and Publicity for the Exhibition

The Lee County Alliance for the Arts and Arts4All Florida reserve the right to photograph or otherwise reproduce the Works for marketing purposes only, both for the Exhibition and for future general marketing and publicity of the Alliance. *The Lee County Alliance for the Arts and Arts4All Florida will take reasonable steps to protect Artist's copyright at all times but the Artist understands and accepts the risk associated with marketing the Works on the Alliance's or Arts4All Florida website and otherwise.*
